DIRECTIONS TO BAYFIELD FARM

From South: Take Hwy. 50 towards Creedmoor. Go through Creedmoor (keeping on Hwy. 50/15) towards Oxford. Before you get into Oxford (2nd stoplight-there is a gas station on right/Used Car lot on left), take a left onto the Oxford Loop. Keep following the Loop until you get to Hwy. 96, turn left onto Hwy. 96 and Bayfield is ½ mile down Hwy. 96 on your left. Look for Bayfield sign.

From North: Take Hwy. 15 towards Oxford. Take a right onto Oxford Loop, until you reach Hwy. 96, turn right onto Hwy. 96, Bayfield is ½ mile down Hwy. 96 on your left. Look for Bayfield sign.

ALL horses must be Inspected by DQP

Every entry shall constitute an agreement that the person making it, owner, lessee, trainer, manager, agent, coach, exhibitor, and the horse shall be subject to the bylaws and the Rules of WHOA, an WHOA Rulebook and the local rules of the show. Further it shall constitute a declaration that the horse and/or exhibitor is eligible as entered and the that the owner and all of its representatives are bound by the bylaws and Rules of WHOA, the WHOA Rulebook and the show and accept as final the decision of the Hearing Committee, or WHOA as the case may be, on any question arising under said bylaws and Rules, and agree to hold the show, WHOA, their officials, directors and employees
