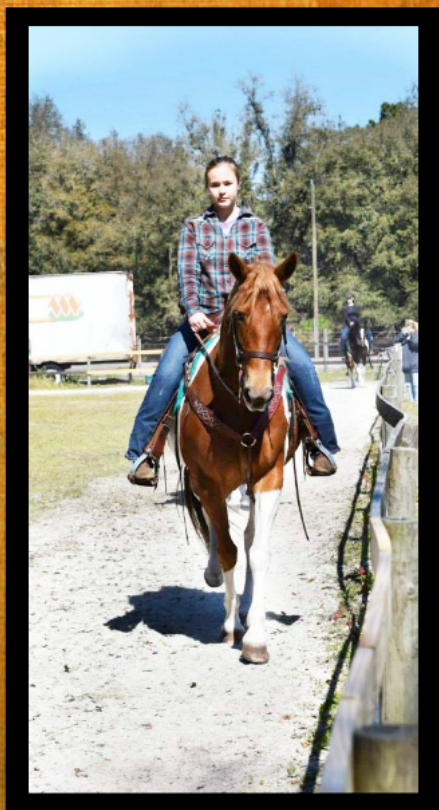

5041 Reece Rd, Plant City, FL 33567

Coming from I-4:

- Take the **Branch Forbes Rd** exit, **EXIT 17**.
- Head South on Branch Forbes Rd. 0.1 mi
- **Branch Forbes Rd** becomes **N Forbes Rd**. 0.2 mi
- Turn **left** onto **US Highway 92 W/US-92 E**. 0.7 mi
 - *US Highway 92 W is 0.1 miles past Cindy Kay Dr*
 - *PLANT CITY CITGO is on the corner*
 - *If you reach Dick and Jane Cir you've gone about 0.1 miles too far*
- Take the 3rd **right** onto **N Turkey Creek Rd**. 2.1 mi
 - *N Turkey Creek Rd is 0.2 miles past Haggard Rd*
 - *If you reach Robinson Pines Park Dr you've gone a little too far*
- Turn **right** onto **Reece Rd**. 0.8 mi
 - *Reece Rd is 0.2 miles past Business Ln*
 - *If you reach Sydney Rd you've gone about 0.3 miles too far*
- **5041 REECE RD**.
 - *If you reach the end of Reece Rd you've gone about 0.1 miles too far*

Coming from SR-60:

- Traveling **Westbound** on SR-60
 - Travel **SR-60 W**
 - Turn **right** onto **Turkey Creek Rd**. 3.7 mi
 - *Turkey Creek Rd is 0.1 miles past Calhoun Rd*
 - Turn **left** onto **Reece Rd**. 0.8 mi
 - *Reece Rd is 0.3 miles past Sydney Rd*
 - *If you reach Business Ln you've gone about 0.2 miles too far*
 - **5041 REECE RD**.
 - *If you reach the end of Reece Rd you've gone about 0.1 miles too far*
- Traveling **Eastbound** on SR-60
 - Travel **SR-60 E**
 - Turn **Left** onto **Turkey Creek Rd**. 3.7 mi
 - *Turkey Creek Rd is 0.1 miles past Calhoun Rd*
 - Turn **left** onto **Reece Rd**. 0.8 mi
 - *Reece Rd is 0.3 miles past Sydney Rd*
 - *If you reach Business Ln you've gone about 0.2 miles too far*

Helmets required for 17 & Under/ Youth Classes

***The Trail Obstacle course will be run with a separate judge. We ask that everyone please complete the trail obstacle class by 2 p.m.**

- For Classic Park classes – no Tungsten allowed.
- If someone needs a tack change, please make that request prior to the show at the entry office. Unless a tack change has been requested the gate will be held for 3 minutes prior to the start of the class.
- No one will be allowed to add any classes after class 7 has shown. There is no penalty to scratch.
- Please bring your Current Negative Coggins to the entry table.



Florida Walking & Racking Horse Association Release Form
(one must be signed by each participant)

I understand horseback riding & related activities are very dangerous & involve the risk of serious injury and/or death, and /or property damage, including injury and/or death to horses, spectators & others. I understand that our horse(s), by being on Green Acres Stables' property, may be exposed to harmful bacteria & viruses, & I assume the risk of possible exposure. Participating in shows, riding horses and attempting obstacle courses can be dangerous and involve the risk of serious injury or death. Accordingly, I agree any activity engaged in by me while participating in activities with the Florida Walking & Racking Horse Association and Green Acres Stables will be done at my own risk. Accordingly, I release & agree to hold harmless the Florida Walking & Racking Horse Association and Green Acres Stables, the lessees, their officers & directors & the owner of the property & any & all persons or entities who are guarantors or indemnitors of the above, all agents, employees, & promoters, sponsors, other riders, horse owners, advertisers, sales persons, photographers, volunteers, (hereinafter called "Releasees") for all liability for negligence or otherwise. I assume full responsibility for the risk of bodily injury, illness, death of myself &/or horse(s), & any other property damage due to the negligence of Releasees or otherwise while on premises or engaged in horseback riding related activities, &/or while training, riding, competing, officiating, observing, teaching, working for, or for any purpose related to horseback riding, eventing or participating as a rider or spectator in such activities. I agree not to sue any Releasees & I release & agree to indemnify Releasees from & for all liability for the undersigned, his/her person, representatives, assignees, heirs, & demands therefore on account of injury to the person, or property or death of the undersigned whether caused by negligence of the Releasees or otherwise. I agree that this Release, Waiver & Indemnity Agreement is intended to be as broad & inclusive as is permitted by the law of this state where these activities are conducted, and if any part hereof is held invalid, it is agreed that the balance shall continue in full force & effect.

All riders 17 years of age and under must wear an approved equine riding helmet when riding a horse on the premises at all times.

I have read & voluntarily signed the Release & Waiver of Liability & Indemnity Agreement & further agree that no oral representations, statements or inducements, apart from the foregoing written agreements, have been made nor shall be made except by a written and signed Addendum.

WARNING: Under Florida law (Statute 773.04), an equine activity sponsor or equine professional is not liable for an injury to or the death of, a participant in equine activities resulting from the inherent risks of equine activities.
