- 1. ALL DOGS MUST BE ON A LEASH AND IN A HANDLERS HANDS
- PINE SPUR HUNT CLUB SHOW MANAGEMENT, ANY MEMBERS, FAMILIES, ORGANIZERS, VOLUNTEERS, PROPERTY OWNERS OR EMPLOYEES ASSUME NO RESPONSIBILTY IN CASE OF, LOSS, OR DAMAGES TO HORSES, PERSONS, OR PERSONAL PROPERITY FOR ANY CASE AND ADMITTANCE. ENTRIES ARE ACCEPTED ONLY ON THAT BASIS.
- 3. VIRGINIA DEPTMENT OF AGRICULTURE REQUIRES THAT ALL EQUINE ON THE SHOW GROUNDS MUST HAVE A CURRENT (WITH IN 12 MONTHS) NEGATIVE COGGINS TEST ON FILE IN SHOW OFFICE BEFORE START OF SHOW.
- 4. CHANGES TO CLASSES OR ADDITIONS TO RULES ANNOUNCED ON SHOW DAY TAKE PRECEDENCE OVER PRINTED MATERIALS WE HAVE THE RIGHT TO CHANGE, COMBINE, OR CANCEL CLASSES.
- 5. PLEASURE CLASS MEANS NO ARTIFICIALE APPLIANCES.
- 6. HORSES ARE NOT REQUIRED TO QUALIFY FOR STAKE OR CHAMPIONSHIP CLASSES.
- 7. APPROPRIATE ATTIRE IS STRONGLY ENCOURAGED, HELMETS WILL NOT BE PENALIZED.
- 8. SCHOOLING IS ALLOWED IN BIG RING BEFORE SHOW STARTS UNTIL 4:30 AND WARM UP RING WILL BE OPEN FOR FULL SHOW.
- 9. THE VIRGINIA EQUINE LAWS ARE IN EFFECT AT ALL SHOWS.
- ANY ENTRANT EXHIBITING UNRULY OR DANGEROUS BEHAVIOUR WILL BE ASKED BY MANAGEMENT TO LEAVE THE SHOW GROUNDS.
- 11. PERSONS ON FEDERAL DISQUALIFICATION CANNOT TRANSPORT HORSES TO THIS SHOW AND CAN ONLY PARTICIPATE AS A SPECTATOR.
- 12. JUDGES DECISIONS ARE FIN/ FINAL.

- 14. STALLS AVAILABLE DAY OF SHOW \$20.00 EACH
- 15. ADDS AND SCRATCHES NEED TO BE DONE 3 CLASSES BEFORE OR REFUNDS WILL NOT BE GIVEN.
- 16. OPEN TABS MAY BE USED WITH SIGNED OPEN CHECK IN ENTRY BOOTHE.
- 17. WAIVERS MUST BE SIGNED AND ON FILE IN ENTRY BOOTHE BEFORE START OF SHOW.
- 18. DQP FEES WILL BE ADDED FOR WALKING and RACKING CLASSES
- 19. NO REFUNDS WILL BE GIVEN TO HORSES THAT DO NOT PASS PRE-SHOW INSPECTION
- 20. WE RESERVE THE RIGHT TO CANCELL SHOW FOR ANY UNFAVORABLE CONDITIONS DUE TO WEATHER
- 21. IN THE EVENT A HORSE PULLS A SHOE DURING A CLASS SEVEN MINUTES WILL BE ALLOWED TO REPLACE SHOE.
- 22. NO RIDING OF BICYCLES OR MOTORCYCLES ALLOWED ON SHOW GROUNDS.
- 23. PLEASE HELP US KEEPGROUNDS CLEAN DEPOSIT TRASH IN THE PROVIDED CANS.
